ACTIVITIES RELATED TO TEACHING/TRAINING

Study Visit to UNIBIT (Sofia, Bulgaia) 10.07.2017-14.07.2017

Planed activities:

- Introduction of partners and their institutions, the analysis of a research for the region, education cyber security at the university level (for higher education institutions)
- Submission of the strategic plan of the university and exchange for repair of university courses
- the analysis of partnership with the foreign universities
- the analysis of student's practice, mobility at the university
- analysis of the double diploma or joint degree practice
- Start of the first lines of cooperation, in particular, with use of the Erasmus + program
- Visit of the IT companies and discussion of their policy of training of the employees.
- Profound studying of the training program developed in the field of computer safety and the
 analysis of how the European university has introduced the procedure of accreditation of the
 curriculum.

Study visit to UNIBIT (Sofia, Bulgaria) 29.01.2018-09.02.2018

The goal of the study visit to EU was: Advanced training in the EU, studying of the international experience on development of educational programs and tools tuning of methodology, development of programs of a bachelor degree and professional master degree for development, administrations, managements, protection of computer systems and networks at the enterprises in Moldova, Kazakhstan and Vietnam.

Candidatures for training in the EU have been selected at a meeting of the working group of the project. Requirement: experience in creation of educational programs. By results of selection to the University of Library Studies and information technologies, Sofia, Bulgaria, have been directed PhD in information systems Aktayeva Alkena Umirbekovna and the head of the Center of planning and management of educational process Igonina Yelena Petrovna.

During the educational visit process of education in the sphere of cyber security in UNIBIT has been investigated; specific features of educational process of the University are revealed; methodical materials, training programs of IT of University's faculty are analyzed; the international experiment on development of educational programs and tools tuning of methodology, diagnostics and classification of needs for training, the development of the draft of the educational program which is applied at UNIBIT are studied separate lecture and practical classes at the University of library and IT are attended, the methodical material of UNIBIT regulating use of rating system of the student is analyzed, - consultations with the faculty of UNIBIT are held, - the pedagogical technologies applied in UNIBIT according to programs of a bachelor degree and professional master degree in the field of cyber security are studied, educational programs of a bachelor degree and professional master degree for development, administration, management, protection of computer systems and networks at the enterprises in Kazakhstan are created.

Following the results of a foreign training within the LMPI No. project 573901-EPP-1-2016-1-IT-EPPKAZ-CBHE-JP program "The program of a bachelor degree and professional master degree for development, administration, management and protection of computer systems and networks at the enterprises of Moldova, Kazakhstan, Vietnam" educational programs of a bachelor and master degrees are created.





Development of syllabuses of subject matters, educational and methodical material on these disciplines is in the future planned.

Training on this educational path at Abay Myrzakhmetov Kokshetau University will be carried out from 01/09/2018.
